

OFFICIAL RULES

Paperblanks® Back-to-School (“Competition”)

By Hartley & Marks Publishers Ltd., Beaux Lane House, Lower Mercer Street, Dublin 2, Ireland (the “Sponsor”)

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE OR IMPROVE YOUR CHANCE OF WINNING.

ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ENTRIES RECEIVED. VOID WHERE PROHIBITED BY LAW. ONLINE ENTRY ONLY AND INTERNET CONNECTION REQUIRED. AFFIDAVIT OF ELIGIBILITY / RELEASE OF LIABILITY / PRIZE ACCEPTANCE FORM MAY BE REQUIRED.

ELIGIBILITY

Void where prohibited by law. Eligible entrants (“Entrants”) must be legal residents of Argentina, Australia, Austria, Belgium, Canada, China, Denmark, Finland, France, Germany, India, Ireland, Italy, Japan, Netherlands, New Zealand, Norway, Poland, Portugal, Russia, Saudi Arabia, South Korea, Spain, Sweden, Ukraine, Taiwan, United Kingdom and United States, except where void. Entrants must be at least eighteen (18) years of age at the time of entry or the age of majority in their country of residency,

whichever is older. Employees, directors and officers and their immediate families (spouses and siblings, parents and children and their spouses) and household members of the Sponsor (defined below), and its parent companies, subsidiaries and affiliates, distributors, dealerships and companies involved in the implementation and execution of the Competition (collectively the "Competition Entities") are not eligible to participate. If the Sponsor decides to reconvene the Competition after a suspension, the determination of the prize winner will be made, from among all eligible, non-suspect Entries received as of the date of the suspension, as the Sponsor determines in its sole discretion.
